It is our hope your schedule will allow you to join us the weekend of March, 26<sup>th</sup> and 27<sup>th</sup> for Educational Day and West Texas Heritage Day.

In order to better serve you please fill out the form completely. Exhibit and housing space is very limited this year. Housing space will be assigned on a first come first served basis. All groups must pre-register! All participants must sign a release of liability.

**Program Description:** Please provide a brief description of your group and the program you will be presenting. We request this information so we can include your group in our handouts to the teachers and the general public.

**On-site Registration:** All participants should go to the big tent to register.

**Early Arrivals:** Please plan to arrive after 1:00 pm on Thursday. Due to site preparations, housing and exhibit areas may not be available any earlier. Please contact Ken Lester or Buddy Garza at 325-396-2358 if you need to arrive before this time.

**Late Arrivals:** Your participation is important to us and we know that some of you have great distances to travel. If you plan to arrive after 10:00 pm please contact Ken Lester or Buddy Garza at 325-396-2358 to arrange for someone to greet you when you arrive so we can provide some level of assistance with getting your group settled and verifying your horses can be unloaded.

**Bringing horses?** Please pre-register your horses if possible. Horse registration requires a copy of a recent Coggins test for Equine Infectious Anemia (EIA). A negative result taken within 1 year of March 27<sup>th</sup> is required before your horses can be unloaded.

**Artillery Crews:** Please indicate how many artillery pieces you will be bringing in the program description and if you intend to fire your ordinance. In an effort to ensure everyone's safety, all members of an artillery crew must be 15 years of age or older.

**Meals:** The staff and Friends of Fort McKavett will be providing three meals on Friday and two meals on Saturday this year. **No** meals will be provided on Thursday night or Saturday night. The fort will provide fire rings and wood for your use in the preparation of your evening meal on Thursday. Our shop kitchen will be open for your use Thursday night between 5 and 8 PM. The following is our preliminary menu (subject to change):

Friday:

Breakfast: sausage, pancakes, fruit, cereal, juices, coffee

\*Lunch: Ham or turkey sandwiches, chips, cookie, and drink
